- Florida's high rate of refusals
- Expected increase in drug-related impairment, especially marijuana and prescription drugs
- Need for more DREs/more DRE Training
- Establishments overserving alcohol

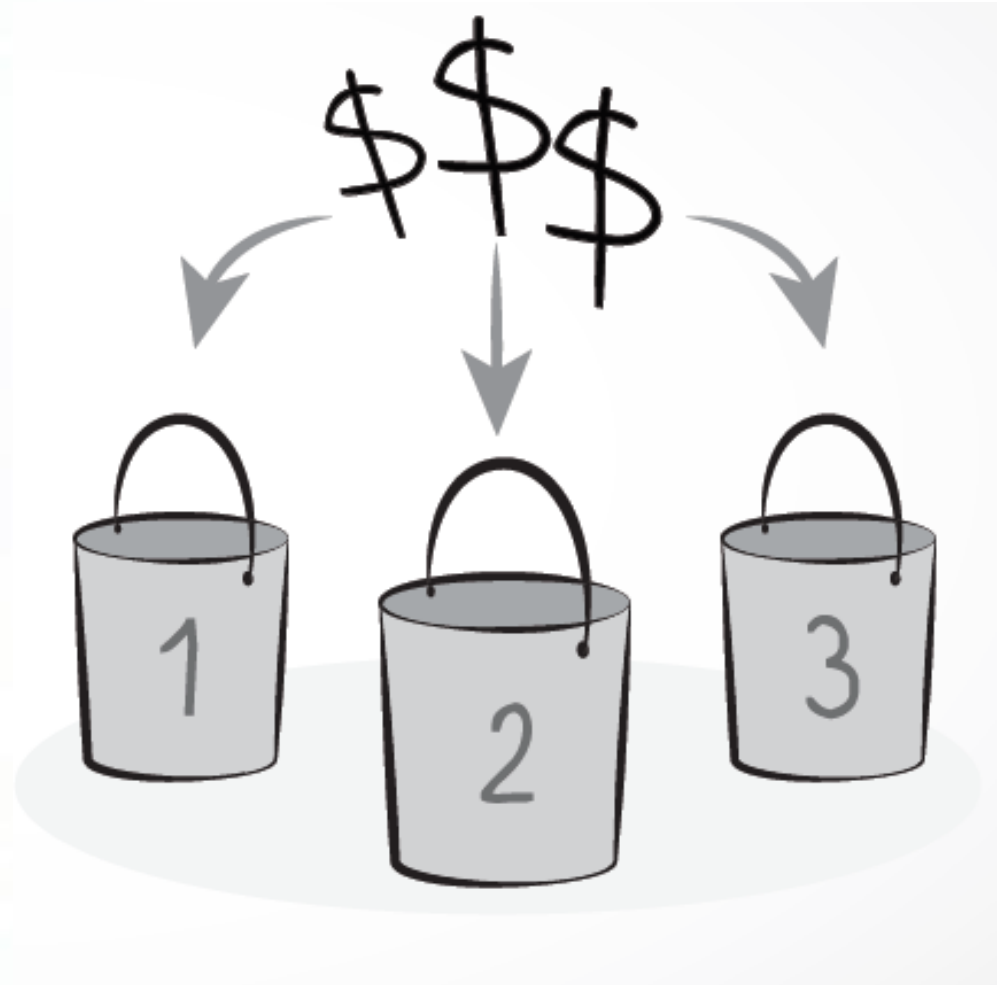

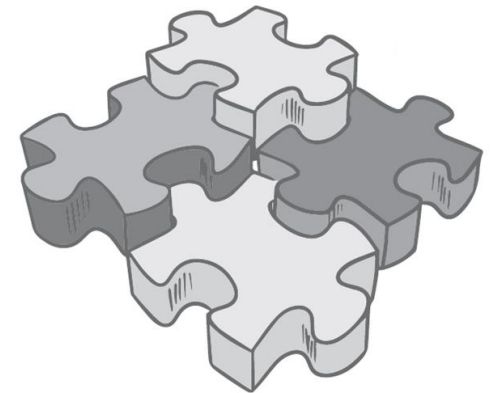
