Chris Craig

- → SB 918 First time refusals
 - » Died in appropriations 5/5/2017
- ➤ SB 858/HB895 Blood draw warrants
 - » Died in Criminal Justice subcommittees 5/5/2017
- SB 784/HB 545 Withhold of adjudications for DUI defendants ordered/electing for ignition interlocks
 - » SB, tabled 5/4/2017
 - » HB died in returning messages; indefinitely postponed and withdrawn from consideration 5/5/2017

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » MJ and MJ delivery devices exempted from the taxes imposed under the chapter
 - Defines caregiver as a resident of the state who has agreed to assist with a qualified patient's medical use of MJ, has a caregiver ID card, and meets the minimum requirements in subsection (6)
 - » Defines "Low THC"
 - Plant of cannabis, the dried flowers of which contain 0.8% or less of THC and more than 10% of cannabidiol or compound, make, salt, derivative, mixture or preparation from the plant or seeds or resin dispensed from a MMJ treatment center

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » Defines medical use
 - Acquisition, possession, use, delivery, transfer or administration of MJ authorized by a physician certificate
 - » Identifies qualifying medical conditions
 - » Physician certification
 - Must have conducted a physical examination of the patient, while in the same room, and a full medical assessment of the patient's medical history
 - Diagnose the patient with at least one of the qualifying medical conditions

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » MMJ treatment centers
 - Initially set at 10
 - When registrants reach 100,000, four (4) additional MMJ treatment centers will be approved
 - Thereafter, four (4) additional centers will be licensed within six (6) months after the registration of each additional 100,000 patients
 - May not established or operate more than 25 dispensing facilities, but could increase by 5 per 100,000 patients registered

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » Penalties
 - 1st degree misdemeanor
 - Doctor providing certification to patient without a reasonable belief the patient is suffering from a qualifying condition
 - Person who fraudulently represents that they have a qualifying condition for the purpose of being issued certification
 - Patient who uses or caregiver who administers MJ (except for low THC) in plain view of or in place open to public, on school bus, vehicle, aircraft or boat, or grounds of a school

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » Penalties
 - 2nd degree misdemeanor
 - Patient or caregiver failing/refusing to present MJ ID card on request of LEO
 - Caregiver who violates any of the rules
 - Subsequent violations are a 1st degree misdemeanor
 - Person who transports MMJ who fails to give ID card

- SB 8-A Medical Marijuana (MMJ) (passed, awaiting signage from Governor)
 - » Penalties
 - 3rd degree felony
 - Person who manufacturers, distributes, sells, gives, or possesses with intent to do the same, for MJ or MJ delivery devices held out to have originated from a licensed MMJ facility (counterfeit)
 - Possessions of fraudulent ID card (blank, stolen, fictitious, forged, counterfeit, etc.)

Update on Data Needs from Previous Meeting

- How is breath test refusal data collected and updated in other states?
 - » Most states do not have a centralized system to keep BAC test records.
 - Some agencies and entities still use paper, thus records are not always updated.
 - Many states do not record test requests that didn't result in a refusal or failure.
- How are other states tracking the number of LEO trained for ARIDE/SFST?
 - Tracked by the International Association of Chiefs of Police (IACP) through Drug Evaluation and Classification Program (DECP).
